

## about DOMESTIC VIOLENCE NSW

Domestic Violence NSW Inc. is the peak body for specialist domestic and family violence services in NSW. DVNSW provides a representative and advocacy function for specialist services and the women, families and communities they support. Our mission is to eliminate domestic and family violence through leadership in policy, advocacy, partnerships and the promotion of best practice. We work with our members, state and federal government and communities to create a safer NSW for all.

DVNSW member services represent the diversity of specialist services working in NSW to support women, families and communities impacted by domestic and family violence including:

- Crisis and refuge services
- Transitional accommodation and community housing providers
- Family support services
- Neighbourhood centres and drop in centres
- Specialist homelessness service providers
- Men's behaviour change programs and networks
- Community organisations working with high risk communities
- Specialist women's legal support services
- Women and children's support services
- Safe at Home programs

DVNSW members are all non-government organisations, some entirely government funded, others supported through philanthropic donations or through partnerships with industry or the corporate sector. Many of our members have multiple government and non-government funding streams. DVNSW advocates for best practice, continuous system improvements and innovative policy responses to domestic and family violence including building workforce capacity and representation at all levels of government.

We provide policy advice to multiple departments in the NSW Government on prevention, early intervention and response. We work with communities and the media to increase awareness and represent the sector on a number of state and federal advisory bodies including the NSW Premier's Council on Homelessness, the NSW Domestic and Family Violence and Sexual Assault Council, the NSW Early Intervention Council, the **NSW Reference Group for Men's** Behaviour Change, ANROWS' Practitioner Engagement Group, and the Australian Women Against Violence Alliance. We co-convene and provide a secretariat function for the NSW Women's Alliance with Rape and Domestic Violence Services Australia.

We acknowledge the work and value of specialist women's services and the practice wisdom of domestic and family violence practitioners that underpins our work. DVNSW thanks the services and individuals who have developed best practice over decades of working with women, children, families and communities and shared their expertise with us over the year. We pay tribute to those who have experienced domestic or family violence, to their families and to our advocates, colleagues and partners in government and nongovernment agencies.

# advocacy AND SUBMISSIONS

DVNSW made a record number of detailed written submissions to the Commonwealth and to NSW Government inquiries reflecting practice, resource and policy challenges identified through the work of our services across NSW. Written submissions are available on the DVNSW website except in the case where the inquiry is confidential. Some of our submissions during the year include:

Commonwealth Attorney General and Family Law Council's discussion paper on "Families with Complex Needs and the Intersection of the Family Law and Child Protection Systems

An unprecedented amount of feedback was received from DVNSW member services in relation to this long awaited discussion paper on Family Law. Our members identified that the Australian Family Law system routinely fails to protect those who need it, despite positive, evidence-based, domestic violence-informed policy amendments adopted in 2012.

DVNSWs recommended substantial improvements to policy and practice to ensure that the safety of children and young people is prioritised in Family Court practices. We highlighted the need to develop a range of comprehensive strategies so that workers in all parts of the Family Law system are trauma-informed, and wherever possible, trauma-specialist approaches are adopted by both the Family Law Court and the Children's Court.

Our submission highlighted that if we are to work effectively and fairly with women, children and families in a way that improves their safety, a comprehensive understanding of the nature of violence in the family context and the impacts of trauma on women, child, young people and communities must be integrated at all levels of legal proceedings including preparatory processes prior to the jurisdiction of the Family Court.

### NSW Social Issues Committee: Inquiry into service coordination in communities with high social needs

DVNSW made a submission to the Legislative Council in late 2015 based on issues identified by member services. In addition to the written submission we were asked to appear before the committee to give evidence in relation to the impacts of Going Home Staying Home, communities impacted by DFV and effective service coordination. The Committee's report was released and made strong recommendations in areas that DVNSW put forward:

- Reviewing the competitive tendering process for human services
- Extension of funding periods to a minimum of 5 years with opportunities for extensions
- Longer lead times for tender preparations
- Codesign processes between government, communities and NGOs.

## Women NSW DFV Blueprint 2015-16

After months of consultation with DVNSW members and broader sector specialists DVNSW submitted a detailed response to Women NSW's Blueprint scoping process. The paper reflected DVNSW member and partner expertise and made recommendations to NSW Government for better resourcing for the domestic and family violence sector.

We also emphasised the unique role of peaks in developing and supporting a sustainable, robust and accountable domestic and family violence system and continued our advocacy for further investment in specialist crisis, housing and longer term responses to meet increasing demand in refuges, women's and family services and other frontline support services as well as community-led responses to Aboriginal Family Violence, Culturally and Linguistically Diverse Communities, women with disability and other high-risk groups.

#### Department of Justice: Interventions for higher risk offenders.

DVNSW's submission focused on the case for funding of nuanced, evidence-based NGO work with perpetrators, as well as the highly-skilled partner and family support work undertaken by specialist DFV services. We highlighted the best practice partnerships between locally based Men's Behaviour Change Programs ((MBCPs) and specialist DFV services.

20% of DVNSW member organisations either currently deliver Men's Behaviour Change Programs or consider men's behaviour change work as a service specialisation area. Frontline domestic and family violence services that do not directly work in the area of perpetrator interventions are nonetheless impacted by interventions with high risk offenders through their work with victimsurvivors and families regardless of whether or not the perpetrators are engaged in formal interventions.

# Working WITH NSW GOVERNMENT

We have monthly meetings with Pru Goward, Minister for Prevention of Domestic Violence and Sexual Assault and a quarterly meeting with **Brad Hazzard, Minister for Family** and Community Services. We had regular meetings advocating for policy improvements throughout the year with a number of government departments including Ministry of Health, Department of Education, Department of Justice, NSW Police and Corrections in 2015-16 as well as local district staff.

#### **NSW Women's Alliance**

The NSW Women's Alliance works collectively to provide a unified voice on issues affecting the NSW domestic and family violence and sexual assault sector. It's a group of non-government peak and statewide organisations working from feminist, human rights and social justice perspectives to improve policy and practice responses. The Alliance brings together a range of agencies with a variety of expertise, knowledge and experience in both responding to, and working towards preventing, violence against women. DVNSW provides the secretariat function of the NSW Women's Alliance, facilitates meetings in a co-chair capacity, and manages submissions and official correspondence for the Alliance. In the 2015-16 year NSW Women's Alliance worked closely with government providing advice and advocacy on a range of issues with a particular focus on demand and capacity in services and unaddressed policy gaps.

#### **NSW 2016 Budget Analysis**

In May 2016 after the release for the NSW state budget, the NSW Women's Alliance released a comprehensive analysis of the NSW Budget. The analysis looked at every element of the state budget likely to have an impact upon victim-survivors as well as the domestic and family violence sector. It built upon previous work of the NSW Women's Alliance "A Safer State" and highlighted the need for adequate resourcing and consistent approaches across NSW's legal, justice, service support, housing, health and education sectors.

# SHAS INDUSTRY PARTNERSHIP PROJECT

NSW Department of Family and Community Services funds an Industry Partnership (IP) that consists of the three homelessness peaks (Domestic Violence NSW, Homelessness NSW and Yfoundations) for the implementation of the Sector Development Project (SDP) to June 2017. The SDP assists the NSW specialist homelessness sector to implement key priorities under the Industry Development Strategy and to build the sector's capacity over the longer-term.

Our Project Officer, Emily Goldsmith, is employed to implement Project C-service access, design and delivery. A key element of this project has been to consult with the sector around the key issues (both systemic and reform based) that impact their service delivery. This consultation has included meeting with services face to face, attending district meetings such as the **District Homelessness Implementation** Group meetings, regional DFV meetings and relevant meetings/forums (such as the **Forced Marriage Network**, local DFV

Committees and networks). From this consultation process, the work relating to developing draft Best Practice Guidelines and the training workshops on working with migrant women impacted by DFV were developed.

A key aim of Emily's project is to bring the sector together to improve collaboration and to explore systemic issues relating to DFV in the current policy space. On 2 November 2015, we convened a statewide forum attended by 74 frontline DFV workers and managers from SHSs from across the state, to explore ways to better work together and ensure those impacted by domestic and family violence receive best practice support and care. A major focus of the forum was on the role of DVNSW and **Homelessness NSW** as peak bodies in advocating for services and appropriate responses through improved policy and funding. In order to influence policy changes to improve the lives of women and children impacted by DFV, regular meetings are held with Link2Home, **DV Line** and senior staff from

the Department of Family and Communities (including NSW Housing, the Homelessness Policy Unit and Community Services).

These meetings have resulted in positive policy changes such as ensuring any person impacted by DFV is given appropriate access to appropriate temporary accommodation, with funding to relocate her if required. Regular meetings are also conducted with Homelessness NSW and Yfoundations to keep abreast of common issues/concerns and policy updates in the homelessness and youth space.

# DVNSW & IARC Partnership

### Improving responses to migrant women impacted by DFV

We've been overwhelmed with stories from migrant women who have no access to income and are experiencing domestic and family violence. This group of women are not entitled to Centrelink benefits or work rights, or are unable to find paid work. In our experience, this cohort primarily includes women who have arrived as spouses or partners of skilled migrants, NZ residents who arrived after 2001 and other visa categories that have restrictions. Women and children impacted by domestic and family violence with no access to an income rely heavily on the domestic and family violence (and the homelessness) sectors for support in NSW. The particular circumstances of these families' results in long stays in homelessness and domestic and family violence support accommodation with no exit options, which also prevents entry of new families to that service.

Our sector reported that they struggled to know how to best assist these vulnerable women. The complexities of migration law are often overwhelming and services reporting feeling like they did not have the training or resources to be able to assist these women confidently.

DVNSW has partnered with the **Immigration Advice and Rights Centre** to provide training to any staff member working with this client group on migration law. Three training sessions were provided in the first half of 2016 in Campsie, Liverpool and Maitland.

All of these training sessions were at capacity – highlighting the desire within the sector for more information on this issue. This training continues to be delivered to DFV specialist services, Police and other interested staff.

The training provides participants with a strong picture of the work IARC do and how they can assist services, what family violence provisions are and how they apply, information around protection visas and information on other family visas. Results from the evaluation surveys highlight the usefulness of the training. At the Liverpool training session, all attendees marked that they were either really satisfied (90%) or pretty satisfied (10%) with the training. All participants cited that they either strongly agreed or agreed that it was worthwhile to participate and that they learnt new skills and knowledge that they would share with others. This positive feedback was consistent across the other training days in Maitland and Campsie.

The success of the training has been acknowledged both from within and outside of the sector – as the partnership was recently nominated for a NSW Law and Justice Award. DVNSW and IARC continue to work together in the 2016-17 financial year, with further training sessions scheduled and an ongoing commitment to support migrant women impacted by DFV.



# Seveloping BEST PRACTICE STANDARDS

Building on the decades of expertise developed by the **NSW Women's Refuge Movement**, Access and Equity Manual principles, specialist services working with women, families and communities (and agencies and services in other jurisdictions) DVNSW has begun creating a sector-driven set of Practice Guidelines and Standards that we hope will be a useful benchmark for DFV support and future allocation of funding for DFV service provision.

Best practice standards will ensure that victim-survivors are provided with consistent, quality support across NSW. Standards will provide services with a clear framework to deliver trauma-specialist responses, demonstrate the value of specialist service provision and benchmark against other similar organisations for continuous improvement. We envisage that the standards will provide options for services and practitioners to work from minimum to best practice. As part of the project we are working with services to put together a comprehensive toolkit of resources, policies, templates and models for practice.



As an initial scoping, Emily our Project Officer conducted a thorough literature review exploring existing standards and guidelines relevant to the DFV sector - both in NSW and elsewhere in Australia. This provided us with a framework to begin talking to services about what they identified as essential principles and practice when working with vulnerable, trauma-impacted families. Consultations with services took place in Lismore, Kempsey, Dubbo, Cobar, Walgett, Brewarrina, Bourke, Griffith, Tamworth, Armidale, Wagga Wagga, Junee, Orange, Bathurst, Port Macquarie, Coffs Harbour, Broken Hill, Wilcannia, Maitland, and Sydney. Additional consultations are scheduled for 2016-17. We asked workers and managers what they thought was important in terms of core principles for specialist responses and key themes for the guidelines.

In the 2016-17 financial year, DVNSW will continue our sector consultations and to work closely with practitioners and experts on the ground to share examples of what works. We've developed a survey to gather additional feedback and detailed examples of practice in a range of community settings and we expect to have a first draft of the guidelines ready to share with you by December 2016. Our new DVNSW Policy and **Advisory Committee** (practitioners from a range of DFV specialist services across NSW) will oversee and provide comment throughout the process and we'll continue to listen to what communities are identifying that they need.

The consultation process to date has highlighted a strong, unanimous desire and support from across the NSW sector to have a set of best practice guidelines/standards in place and to have measures and benchmarks that value professional, specialist responses to women, families and communities impacted by violence.

We look forward to updating you on the completion of this work in the next DVNSW Annual Report.

# DVNSW ANNUAL MEMBER Survey

In June 2016 DVNSW gave members the opportunity to respond to our annual member survey. Over the four weeks the survey was open, 75% of our member organisations responded with valuable insights into the ways in which DVNSW can improve our communication strategies, reflection upon the ways in which DVNSW has contributed to the positive outcomes of member organisations as well as highlighting areas of priority of work for DVNSW in the coming 2016-2017 year.

The results of the survey are informing our organisational planning for the next year and will allow DVNSW to experiment with new ways of keeping our members updated in a timely, relevant and concise manner. DVNSW will be focusing on increasing the number of members who can engage and contribute to submissions and our policy work as well as advocacy campaigns as a result of the insights contained within the survey feedback.



#### Advocates Support Roll-Out Of Program Across New South Wales To Target Domestic Viole...

"That means working across the community to change attitudes and behaviours of some men that feel it is their right to control and abuse women."

According to Moo Baulch, CEO of Domestic Violence NSW, the new program sends a strong message that police do not accept domestic violence and will be targeting individuals who are serial perpetrators.

"I think it's a new way that police are going to be targeting the particularly high-volume offenders," Baulch told The Huffington Post Australia.

"I think things are really shifting about the way police are dealing with domestic violence," she said.

The CEO of Domestic Violence NSW, Moo Baulch, said rates of abuse in LGBTI relationships was similar to that between straight couples but awareness of the issue was lagging far behind.

"We find it hard to talk about this stuff in the same way that we do in the mainstream spectrum. It's a hidden thing, it happens in people's homes, there's a level of fear or shame about seeking support and you have these extra levels in LGBTI relationships."

CEO of Domestic Violence NSW, Moo Baulch, said the video did a great job addressing how we have to change sexist attitudes before we can really end violence against women. "Abuse of women and girls, particularly the insidious sexist name-calling, denigration, and put downs, is often explained away as being a joke or insignificant," she said, noting that it's those very jokes that help to encourage people to mistreat women in more severe ways.

Australian Prime Minister Malcolm Turnbull put it well when he recently addressed the "boys will be boys" attitude toward domestic violence, saying, "Let me say this to you: disrespecting women does not always result in violence against women. But all violence against women begins with disrespecting women."

Baulch added that the world needs more men to be "vocal role models, men who are willing to make the sorts of connections between disrespect and violence against women that [Prime Minister] Turnbull made a few weeks ago. That was incredibly powerful."

good enterprise. DFV survivors are employed in the Two Good Kitchens and trained, paid and supported in their pathway to recovery. Two Good has expanded to Melbourne now and a number of top Sydney and Melbourne chefs continue to develop new dishes and recipes whilst doing good wherever they go.
